RE: 12, 13 AND 14 BLOOMSBURY SQUARE RELOCATION OF CONDENSERS

We have been informed that the proposed location of the condensers of the above site has changed. We have reviewed and assessed the new location based on Samuely Construction Structural Engineers drawing 3786-01 dated January 2012.

We reference to our Environmental Noise Survey and Plant Noise Assessment Report 17143/PNA1 dated 15 April 2011, we have previously advised acoustic enclosures or the re-selection for the condensers to be installed on 12 and 14 Bloomsbury Square. We understand the choice of noise mitigation is acoustic enclosures.

The new scheme would require that all 3No. condensers are housed in acoustic enclosures to the same specification i.e. 47dBA measured at 1m in all directions.
