# **Listed Building Consent Granted**

## Proposal:

Installation of 2 windows and enlargement of existing lightwell at lower ground floor level of the west elevation of the central block and internal alterations including removal of suspended ceiling all in connection with the existing school (Class D1).

Drawing Nos: (1937.PL.)001 [Site Location Plan]; 002; 003; 004; 005; 006; 007; 008; 009, 021; and 022.

The Council has considered your application and decided to grant Listed Building Consent subject to the following conditions:

# Conditions and Reasons:

1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed



Buildings and Conservation Areas) Act 1990.

2 No development shall take place before detailed plan, elevation and section drawings of windows showing exact detailing of cills, arches, reveals and glazing bars at scale 1/10 are submitted to and approved in writing by the Council. The works shall be carried out in accordance with the approved details.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

3 The works hereby approved are only those specifically indicated on the drawing(s) referred to above.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

4 All new external and internal works and finishes and works of making good to the retained fabric, shall match the existing adjacent work with regard to the methods used and to material, colour, texture and profile, unless shown otherwise on the drawings or other documentation hereby approved or required by any conditions attached to this consent.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.
