- 3 Details in respect of the following, shall be submitted to and approved in writing by the Council as local planning authority in consultation with English Heritage before the relevant work is begun. The relevant work shall be carried out in accordance with such approved details.
 - a) A section of pipework, showing fixings, jointing details, sealant details etc. is to be erected on site for approval by the Council and local planning authority in consultation with English Heritage.
 - b) Annotated photographs/drawings of internal pipe runs, showing interior works and locations of related equipment.
 - c) A method statement detailing the proposed method for undertaking the proposed work, including scaffolding and details of fixing, and ensuring safety during the implementation of the works shall be submitted and approved by the Council as local planning authority.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.
