1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at 118 Cleveland Street London W1T 6PD

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission: The unauthorised installation of upvc windows on the property's front elevation at ground floor level.

4. REASONS FOR ISSUING THIS NOTICE

- a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**.
- b) The unauthorised upvc windows, by virtue of their materials, design and means of opening are considered to cause visual harm to the building and fail to preserve and enhance the character and appearance of the Fitzroy Square Conservation Area. The windows are therefore considered to be contrary to policies CS5 (Managing the impact of growth and development) CS14 (Promoting high quality places and conserving our heritage), DP24

(Securing high quality design) and DP25 (Conserving Camden's heritage) of the Local Development Framework.

5. WHAT YOU ARE REQUIRED TO DO

- Remove all of the upvc windows from the property's front elevation at ground floor level.
- Either re-instate the original design of timber framed windows on the front elevation of the property at ground floor level <u>or</u> implement planning permission 2011/0429/P in accordance with the approved plans (116/118CS/02 and 116/118CS/03).

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **24 July 2012** unless an appeal is made against it beforehand.

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged", there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for planning permission for the development alleged to be in breach of planning control in the enforcement notice.


