BACKGROUND TO PROPOSAL

The building has been, at some unknown time in the past, badly sub-divided into 'bedsit' accommodation. It is unclear from any available planning information if this subdivision is lawful, but for simplicity and the greater good of the Listed Building, the assumption is made that a reversion to the original single family dwelling house is the best solution to the long term future of the building.

GENERAL PROPOSAL

- Lawful demolition and stripping out of 'non-original' fittings, fixtures and material / fabric
- Removal of all 'bedsit type accommodation' and reconfiguration to, and re-instatement of single dwelling house
- Addition of modern and sanitary kitchen, bathrooms, cloakrooms and utility spaces, where possible within the original 'historic' plan form
- Replacement of outdated service provision: water, electricity and heating equipment.


