2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design), and DP25 (Conserving Camden's heritage / conservation areas) of the London Borough of Camden Local Development Framework Development Policies.

3 The development hereby permitted shall be carried out in accordance with the following approved plans [Location Plan EX 000; EX100; EX001; EX002; EX003; EX004; EX010; EX011; EX012; PA 100; PA 001; PA 002 Rev A; PA 003; PA 004; PA010 Rev A; PA 011 Rev A; PA 012; Design & Access Statement by Robert Dye Associates.

Reason: For the avoidance of doubt and in the interest of proper planning.
