The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan; Drawing no(s) SSE/NDL/1 & SSE/NDL/2 Rev B.

Reason:

For the avoidance of doubt and in the interest of proper planning.

The roof of the lower ground floor rear extension adjacent to the Juliet balcony at the rear of Flat 3, shall be used for maintenance purposes only. Under no circumstances shall shall the roof be used as a terrace or sitting out area at any time.

Reason: To protect the amenity of neighbouring residential properties pursuant to Policy CS5 of the Core Strategy and DP26 of the Development Policies of the London Borough of Local Development Framework 2010.

- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
