platforms 1 and 5-8; construction of canopies to south elevation of main train shed and taxi waiting areas; enclosure of London Underground South-East stairs; permanent removal of Porte Cochere and northern canopy to Western Range, Great Northern Hotel porch and other items; demolition and replacement of Handyside pedestrian footbridge and demolition of elements of suburban train shed and of other structures; and other alterations, operations and extensions in connection with new uses and facilities

#### **Assessment**

The application is submitted by Network Rail (NR) to discharge condition 7 on a taxi management scheme which requires-

Details in respect of all new works including the following shall be submitted to and approved in writing by the Council as local planning authority before the relevant work is begun. The relevant work shall be carried out in accordance with such approved details.

- a. Layout details of the taxi pick-up passenger queuing arrangements including any pedestrian crossovers to taxi pick-up island and trolley corrals
- b. Layout details of the taxi drop-off arrangements.

All to be provided at a minimum of 1:50.

Reason: to ensure the highway safety of passengers and other road users and to secure the delivery of high quality landscaping in accordance with policies S10, T15, KC6, B1 and SKC1 of the London Borough of Camden Replacement Unitary Development Plan 2006.

Transport officers and TfL both made criticisms in detail of the originally submitted plan. It has now been revised and is now considered satisfactory to the Council.

TfL have confirmed their broad agreement to this, but comment on 2 aspects- first relates to the ability of taxis to turn right from the rank into Pancras Road. However as a road safety audit did not raise the right hand turn as a hazard, officers consider that this is no longer a concern.

The second issue is with regard to the taxi sharing facility and marshalling. However the condition does not refer to this, as it only specifically requires layout plans; instead aspects of this taxi plan relating to taxi sharing facility and taxi queue management are subject to separate approval by both the Council and TfL as a requirement of the <u>S106 clause 2.92</u> entitled 'the taxi and station perimeter management plan'. Hence it is recommended that an informative be added to the approval reminding NR of the need to continue discussions with the Council and TfL in order to fully discharge the relevant requirements of the S106.
