The Council has considered your application and decided to **refuse** planning permission for the following reason(s):

Reason(s) for Refusal

1 The proposed first floor rear extension, by reason of its bulk, built form, location and



detailed design, would appear as a discordant and overly dominant feature to the rear of the terrace and be detrimental to the character and appearance of the host building and the Dartmouth Park Conservation Area contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.
