Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

- 3 The proposed flue is to be powder coated to match the colouring of the existing roof.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

- 4 The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan; Drawing no(s) 340 M004 A; (prefix201_) 001 T1; 003 T2; 004; 015; 016; 020 T1; 021 T1; 023 T1; 101 T5; 103 T4; 101 T5; 103 T4; 101 T3; 103 T2; 114 T1; 115 T3; 117 T2; 120; 121; 171 T2; 183 T3; 184 T2.

For the avoidance of doubt and in the interest of proper planning.

- 2 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. construction other than within the hours stated above.
