2	Lime	(<i>Tilia spp</i>)	This tree was missed when the other Limes were reduced, suggest reduce and re-shape the crown by 30%, clean out crown, remove epicormic and basal growth.

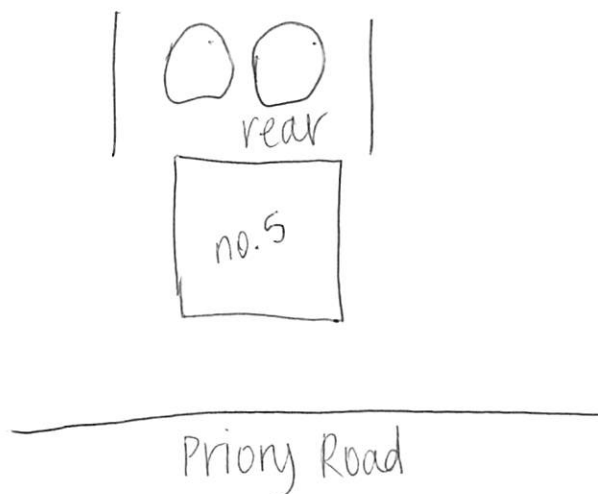
