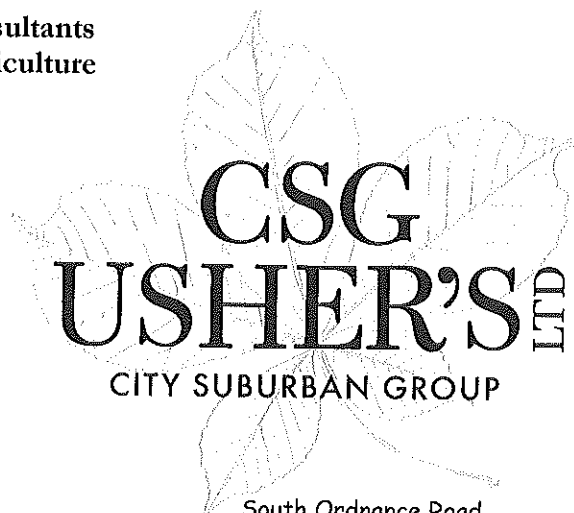

FRONT GARDEN:

T1 = PRUNUS - Tree close to front of building, but given the species it is not deemed to be a subsidence risk. General health of the tree is good.
We recommend - Reduce crown by 20%, reshape and tidy up.

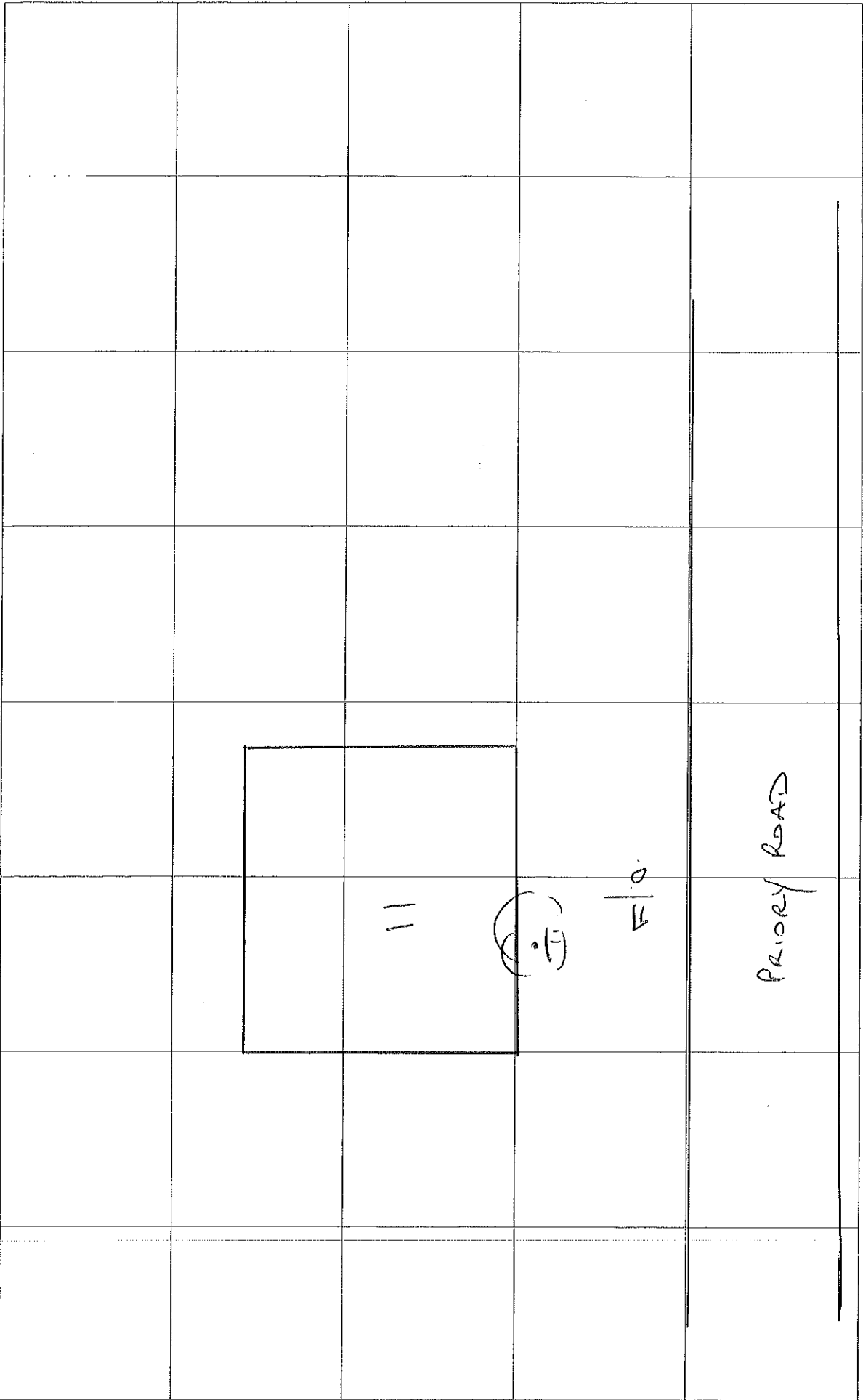
