Replacement of existing metal handrail with a new handrail and widening of walkway along the fourth floor fronting the courtyard at the northern end of the residential block (Class C3). Drawing Nos: 20506-00 dated Dec 2011(Location Plan); 20506/2 (dated Dec 2011); 3 (dated Dec 2011); 4 (dated Jan 2011); and Design and Access Statement prepared by Fresson & Tee Chartered Surveyors.

### Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans: 20506-00 dated Dec 2011(Location Plan); 20506/2 (dated Dec 2011); 3 (dated Dec 2011); 4 (dated Jan 2011); and Design and Access Statement prepared by Fresson & Tee Chartered Surveyors.

Reason: For the avoidance of doubt and in the interest of proper planning.
