1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

2 The development hereby permitted shall be carried out in accordance with the following approved plans: E10016/01 (Site location plan); 02; 03; 04; 05; 06; 07; 08; Supporting letter by Camden Capital Investment Group.

For the avoidance of doubt and in the interest of proper planning.

3 The colour of the proposed microwave antenna and supporting mount shall match as closely as possible the brickwork of the building to which it is attached.

Reason: In order to minimize the impact on the appearance of the building and local environment in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage); of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (High quality design); DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

4 Any cable runs and associated TV reception equipment currently fixed to the external walls of the building which, as a result of the development become redundant shall be removed prior to the completion of the works.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high Quality Places and Conserving Our Heritage) of the London Borough of Camden Local Development Framework Core Strategy; and with DP24 (Securing High Quality Design) and DP25 (Conserving Camden's Heritage) of the London Borough of Camden Local Development Framework Development Policies.
