# **Site Description**

The subject building relates to a four storey block fronting Winchester Road with commercial uses at ground floor level and residential units above. The subject building is noted as a positive contributor within Belsize Park conservation area and backs onto new public open space.

There are five existing satellite dishes, two loose cable runs, and one rear facing antenna on the front elevation of the building.

## **Assessment**

The proposal forms part of a wider scheme organised by the London Borough of Camden for the switch to digital TV transmissions. The programme also provides the opportunity to remove redundant dishes and antennas which prove unsightly.

### Proposals:

- Installation of 2 communal satellite dishes.
- New aerial and associated equipment, including two cabinets.
- External cable runs to each flat.

Belsize Park Conservation Area Appraisal and Management Plan, notes that satellite dishes are not normally acceptable where they are positioned on the main façade of a building or in a prominent position visible from the street. Satellite dishes should be kept to the rear of the property, below the ridge and out of sight at roof level.

#### Amendments:

Initially the antenna was sited towards the rear elevation which fronts onto new public open space behind Hampstead Theatre; as the antenna would be clearly visible from the public realm an amendment to alter its location was requested. The agent has confirmed that other possible cable run routes to these applications were investigated however this would result in major works and disruption to residential amenity.

### 2x Communal satellite dishes and antenna

Two satellite dishes are proposed on the north west elevation of the tank room, 80cm in diameter and mounted on a 2m high pole. The proposed antenna would be affixed to a 4m high pole between the satellite dishes. The existing tank room is sited towards the south east elevation of the building; the satellite dishes and antenna would be sited centrally on the tank room wall to ensure that they would not be visible from the public realm.

The main cabinet proposed would be sited on the inside wall of the parapet 0.6m x 0.6m in light grey.

### **External cables**

The proposed external brown pvc cable will run from the antenna and down the main façade of the building, running to each flat resulting in three vertical lines. The brown cable proposed should blend with the brick colour of the existing building.

Site inspection noted that there are five existing satellite dishes on the front elevation of the subject building with two loose cable runs. The removal of these dishes would improve the appearance of the front elevation and is therefore welcomed.

#### Conclusion

The satellite dishes and associated equipment proposed would not be clearly visible from the public realm and the removal of existing satellite dishes at the front elevation should reduce visual clutter. The external cables proposed are not considered visually obtrusive to the detriment of the character and appearance of the existing building or street-scene within Belsize Park conservation area. As such the proposed works are deemed acceptable in relation to policies: CS5; CS14; DP24 and DP25 of Camden's LDF and Camden Town conservation area appraisal and management plan 2000.

Recommendation: Grant approval.
