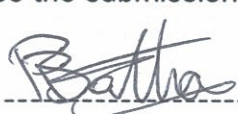

2. BRIEF DESCRIPTION OF DEVELOPMENT	The installation of communal TV reception equipment capable of receiving digital transmissions in readiness for the 2012 switch. The IRS (Integrated Reception System) includes one aerial and two satellite dishes in a location, discreet where possible, but where they have clear line of sight to satellite and transmitter. The installation also includes an external cabinet/junction box and cabling to the individual properties. Two cables run to each property from the junction box. Architectural features of the building are used where possible to disguise the cable runs.
