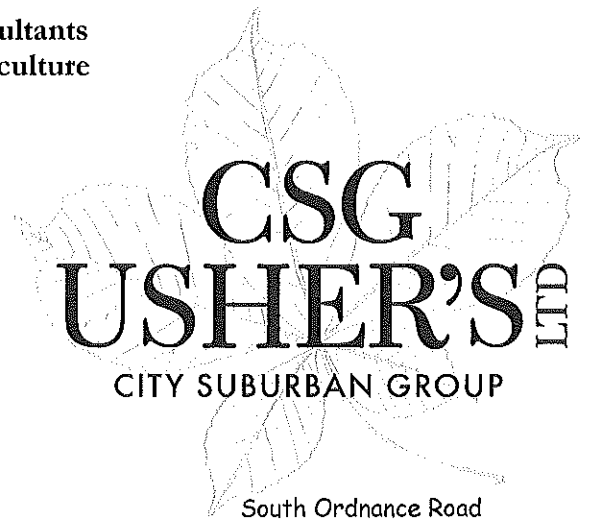

## JOB DESCRIPTION

Following an emergency call out on 10th January 2012 where a Mature Plane tree shed branches into the playground beneath, we have re-inspected all of the trees on this site.

We identified the following trees requiring work:

T5 = MATURE PLANE - Clean through crown removing deadwood. Inspect crown for defects especially massaria infection and submit a written report.

T18 & T19 = 2 x MATURE PLANE - Overhanging playground - Clean through crown removing deadwood. Inspect crown for defects especially massaria infection and submit a written report.

T23 = MATURE PLANE - Overhanging playground - Clean through crown removing deadwood. Inspect crown for defects especially massaria infection and submit a written report.

T25 & T26 = 2 x MATURE PLANE - Overhanging playground - Clean through crown removing deadwood. Inspect crown for defects especially massaria infection and submit a written report.

We noted that Trees 31, 32, 33 & 34 appeared to all be under stress and we would consider seriously reducing the canopies of these trees to promote regrowth further down their branch structure.

4 x MATURE PLANE - Reduce crowns by 35%, reshape and tidy up.
