The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

2 All new work and work of making good shall be carried out to match the original work as closely as possible in materials and detailed execution.

- 3 Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:
 - a) Elevation of bracket for hanging sign at a scale of 1:10 with details of the fixings at 1:1.

The relevant part of the works shall not be carried out otherwise than in accordance with the details thus approved.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

4 Notwithstanding approved drawing GS_111209.3, the approved size of the hanging sign at first floor level is that shown on drawings GS_111209.6 Rev 2012-01-30 and GS 111209.9 Rev 2012-01-30.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.
