There will be a wire run from the array down to the ground floor of the building. The Wire will be run alongside a drain pipe on the East side of the building and painted the same colour as the building so as to reduce the visible impact.

Roof covering- add description

Description of *existing* materials and finishes:

The dwelling is a semi-detached Grade II listed Stucco-fronted villa on the corner of Eton Villas and Eton Road. It has a cornice and blocking course and a flat roof upon which the solar PV system will be installed.

Description of *proposed* materials and finishes:

The installation of a solar photovoltaic ("solar PV") array consisting of six monocrystalline solar panels. The array will be oriented to face South and mounted on the roof using a flat roof closed ballasted system inclined at 10 degrees. The optimum inclination of a solar PV array is 30 degrees, but this array will be inclined at 10 degrees and the mounting system will be closed, rather than an A-frame system, each in order to reduce its visibility from both Eton Villas and Eton Road.
