Front Garden  
Holm Oak - Aprox. 16m - Raise crown over road and garden by aprox. 3m, reduce crown back from 102 Frognal by aprox. 20%, reduce extraneous branches back into main crown structure by 25%, reduce remaining crown by 20%, remove dead wood and thin crown density by 20-25%.  
Reasons - Due to the trees proximity to building and road the above actions will help reduce potential hazards, keep the tree clear of high vehicles, increase light levels to the property and help curtail trees sphere of influence in relation to buildings whilst preserving natural characteristics and aesthetic value.
