Rear Garden

T1: Oak - Remove dead/diseased/broken branches.

T2: London Plane - Reduce crown by 20-25% and thin crown density by 20-25%, remove dead wood.

T3: Holly - Reduce height by 20-25%.

T4: Cornus - Remove ivy from high crown break and thin crown density by 20%.

T5: Birch - Remove ivy to aprox. 5m.

T6: Hornbeam - Remove one low branch at 3.5m South West facing, thin crown density by aprox. 20%, reduce extraneous lateral branches by 20% and raise crown over shrub beds by up to 2m. This action with control encroachment and increase light levels to the flower bed whilst retaining trees health, natural characteristics and aesthetic value.

T7: Eucalyptus - Reduce to a height of aprox. 4.5m.

T8: Oak - Remove dead/diseased/broken branches and remove ivy to a natural line at aprox. 6m.

T9: Yew - Judiciously reduce low overhanging branches by aprox. 20% back into main crown structure and reduce remaining extraneous overhanging branches to control encroachment.

Reasons - General maintenance unless additionally specified above.
