The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The approved side extension shall be used for the enjoyment of the existing dwelling house only and not as a separate residential unit without first receiving Planning Permission from the Council.

Reason: To ensure all self-contained residential accommodation complies with London Borough of Camden Local Development Framework Core Strategies CS1, CS5, CS6 and the London Borough of Camden Local Development Framework Development Policies DP5 and DP6 and Camden Planning Guidance.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

Reason: For the avoidance of doubt and in the interest of proper planning.
