In particular, you should provide: 3 copies of a report by a tree professional (e.g. arboriculturist or horticultural adviser) if your reasons relate to the health and/or safety of the tree(s). 3 copies of a report by an engineer or surveyor, together with one from a tree professional (arboriculturist) if you are alleging subsidence damage.
For works to trees in conservation areas, it is important to supply precise and detailed information on your proposal. You may, therefore, wish to provide the following: 3 copies of a completed and dated form, with all questions answered.
3 copies of a sketch plan showing the precise location of all tree(s).
3 copies of a full and clear specification of the works to be carried out.
