The IRS (Integrated Reception System) includes 3 rigs each with one aerial and two satellite dishes in a location, discreet where possible, but where they have clear line of sight to satellite and transmitter. The installation also includes an external cabinet/junction box and cabling to the individual properties. Two cables run to each property from the junction box. Architectural features of the building are used where possible to disguise the cable runs.
