**BRITISH MUSEUM WORLD CONSERVATION AND EXHIBITIONS CENTRE
DISCHARGE OF CONDITIONS ATTACHED TO PLANNING PERMISSION REFERENCE 2009/4638/P**

We are instructed by the Trustees of the British Museum to submit an application for the discharge of conditions 8 and 11 attached to Planning Permission reference 2009/4638/P.

We set out below the relevant conditions and identify the information that has been submitted to allow for the discharge of the relevant condition.

Condition 8

Condition 8 states:

"Prior to the commencement of the relevant part of the development details of all internal/external plant and the truck lift, including an acoustic report which demonstrates that the equipment will comply with the requirements of condition 8 shall be submitted to and approved in writing by the local planning authority. The development shall be carried out in accordance the details thus approved and shall thereafter be maintained in effective order to the reasonable satisfaction of the Council".

The following documents are submitted to allow for the discharge of this condition:

- 42 Tonne Lorry Lift (Machinery Directive) Technical Specification dated May 2011 and prepared by ARUP; and
- Proposed Drawings as listed in Schedule 1 to this letter.

Condition 11

Condition 11 states:

"The internal lights shall be connected to a presence detection system which shall be submitted to and approved in writing by the local planning authority prior to commencement of the relevant part of development. The development shall be carried out in accordance with the details thus approved and shall be retained and maintained as such thereafter".

The following documents are submitted to allow for the discharge of this condition:

- Particular Specification – Electrical, dated August 2011 and prepared by ARUP;
- Luminaire Specification Sheets; and
- Drawings as listed in Schedule 2 to this letter.

Summary

The above information is in line with that used to discharge conditions attached to the earlier consent and we consider is sufficient to allow the discharge of conditions attached to this consent.

Fees for Discharge
