The application proposes removal of existing sliding folding doors and windows that form the rear wall of the upper ground floor [living room / kitchen] of the house, and replacing it with new sliding folding doors that span the width of the terrace along the line of the existing doors. This involves building out the corner of the volume that is projecting inwards from the terrace by extending the wall and roof at that corner [see drawing In addition, two new skylights will be constructed, one along the wall of the living room and the other, above the existing stairs that lead to the basement which currently receives no daylight.

In order to minimise the impact of the proposed alteration to the existing building, the height, finish and detail of the new sliding folding doors will match the existing doors, and the construction and internal and external finishes of the extension to the walls and roof will match the existing. The existing construction is brick and block cavity with a painted render finish.
