Reduce elder at rear of 25 Grafton Road by 25% and extract overgrown ivy to preserve the tree beneath.

We carried out the same work five years ago but the tree is now overgrown and out of shape (reducing will improve shape and allow light to other plants) and ivy is strangling the tree (extracting ivy will ensure tree survives and help it to flourish next spring).
