The concerning property is situated at the rear of 81 Endell Street. This unit has been and is currently being used as a residential C3 classification. You access the property via a communal pathway running down the length of 81 Endell Street, which is detailed on the plans.

The entrance to the property is situated on the ground floor. The property comprises of a ground floor which contains a living room/Kitchenette and a first floor where a bedroom and en-suite is situated.

In addition my client lets the property on long term leases, the tenancy agreements are our only evidence to prove that the current layout of the site has been the layout for over four years, we do not have any additional information such as Utility Bills and Council Tax receipts to support our case as the tenant pay for them on an individual basis.
