Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans Site Location Plan; Drawing nos C/07/201 C/07/2011/04; C/07/2011/02; C/07/2011/04; Z/07/2011/05; Z/07/2011/06; C/07/2011/07; C/07/2011/08; C/07/2011/09; C/07/2011/10; C/07/2011/12; C/07/2011/11;

Reason: For the avoidance of doubt and in the interest of proper planning.

The roof of the rear extensions hearby approved shall not be used as roof terraces without the written consent of the Local Planning Authority.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.
