To construct a light weight structure made from timber and zinc cladding with a maximum height of 2300mm descending to a lower height of 2200mm. The proposed material will match that of the newly constructed extension helping maintain consistency within the architecture. We are proposing to install 3 roof light at a dimension of 750mm x 500mm to help natural light enter the room and reduce the visual impact of the roof. We are proposing that the length is reduced to 4345mm but relocated near the front of the house. As a result of relocating this construction we are proposing that the timber fencing be extended and that one of our hedges will need to be trimmed back.
