# **Site Description**

The property is located on the north side of the street within the Eton Conservation Area. It is a Grade II listed building which forms one of 8 semi-detached villas built c1849 to the designs of John Shaw for Eton College. They are faced with stucco, channelled at ground floor level and have stucco quoins. They are 2 storeys high plus attics and semi-basements and are 2 bays wide. They have hipped slated roofs with dormers and bracketed eaves. The entrance is approached by a flight of stairs up to a squared portico with round-arched side openings and pilasters.

**Eton Conservation Area Statement** 

#### **Assessment**

The application seeks the installation of a handrail along one side of the flight of steps up to the front entrance of the property. It would comprise a 50mm steel handrail section with 25mm diameter uprights and 75mm diameter fixing plates attached to the side of the 2 of the treads and to the pilaster which carries the portico. With regard to the proposals, consideration should be given to:

- 1. the level of harm caused by the proposals on the special interest and setting of the listed building and the wider group weighed against the public benefits of the proposals
- 2. whether the proposals would preserve or enhance the character or appearance of the conservation area.

The properties are dominant within the streetscape as a result of their elegance and stucco elevations. The Conservation Area Statement notes that detailing, where it survives, is relatively simple (these being from that part of the Victorian age when the simplicity of Georgian domestic architecture was still prevalent). The porticoes and associated flight of steps up to the front entrance of these properties provides an element of grandeur such that the entrance are a well considered element of the architectural design of the building and accordingly form part of its special interest.

The painted steel handrail is proposed to match an existing handrail which has been attached to the steps on the adjacent property, No.19. The properties were listed in 1974 but there are no planning history records to show consent was granted for the handrail at No.19.

The handrail is proposed to provide the occupier with safer access and egress to and from the property and has been recommended by the Social Services Department and the Royal Free Hospital. The handrail is relatively discrete in terms of design and fixing and will be painted white to reflect the colour of the property.

The proposals would cause less than substantial harm to the special interest of the listed building and the wider group. Therefore it is necessary to consider the public benefits of providing safer access for the resident. It is also necessary to consider whether the proposals would preserve or enhance the character or appearance of the conservation area. On balance, it is considered that the less than substantial harm caused would be outweighed by the public benefits to the resident.
