1. Access Statement

After a long period of negotiation to determine an agreed position between the London Borough of Camden, the planning team working on the development of 50-57 High Holborn and Wedlake Bell, who occupy the building on the eastern side of Brownlow Street and their traffic representatives TPP the following points have been agreed with respects to servicing and accessing the 50-57 High Holborn development from Brownlow Street.

- 1) That the new loading bay entrance is moved from the location of the previously consented scheme southwards.
- 2) That refuse collection will take place on street using an Econic Bluetech vehicle xx vehicle
- 3) That the Highway improvements and tracking shown on drawings 36680-W-06-SK03_A07and 36680-W-06-SK04_A05 and 36680-W-06-SK05_A05 appended to this document have been agreed by the Highway Authorities and accepted by Wedlake Bell.
- 4) That it is not necessary under the new scheme to raise any kerb heights on Brownlow Street
- 5) That the use of the new loading bay should be conditioned in any new planning condition to vehicles of 8metres in length or less via a service management Plan to be required as part of the Section 106 Agreement.
