We would now like to invite you to our second public exhibition to view the revised proposals and to provide you with a further opportunity to give us your feedback, prior to submission of a formal planning application to Camden Council later this summer.


The second exhibition will take place over 3 days from **Thursday 16th June through to Saturday 18th June** (please see overleaf for exhibition times and venue). We are proposing to regenerate the Hawley Wharf site with a mixed use development which will deliver an improved Camden Canal Market area, provide over 200 new homes including affordable housing, new and improved employment opportunities via new retail and commercial spaces, a cinema and new public open spaces across the site. There is also a potential for a new primary school within the site. We are confident that our proposal will meet the expectations of the local community.
