T4 Norway Maple: Reduce crown height by approximately 2-3 metres. Reduce lateral branches back to previous.

T8 Oak: Clean through the crown removing all major deadwood and poorer crossing branches. Thin through the canopy by approximately 20%.

T9 Elm: Remove lowest branch over road

TH8 Oak: Trim back to boundary
