



REAR GARDEN


- T1. To the left of the house – 5 small Birch trees to fell and grind out the root bowls.
- T2. Three Sycamore trees beyond the fence – to de-ivy completely.
- T3. Three groups of dead Dutch Elm trees – to fell to ground level only. To also grind out the root bowls.
- T4. Large Sycamore in the centre of the boundary next to the Ash tree – to remove all ivy from the top, leaving 5 metres at the base.
- T5. Ash tree next to the Sycamore – to remove all deadwood down to 2cm and the sucker growth in the crown.
- T6. Group of small Hollies behind the Ash tree – to reduce by 50% to create a small view.
- T7. Conifer in the corner – to fell to ground level only and to grind out the root bowls.
- T8. Hornbeam – to remove the bottom 8 limbs and run the hedge cutter over the rest to form a shape again.
- T9. Conifer beyond the Hornbeam – to fell and grind out the root bowl.
- T10. Two groups of Bay trees next to the step – to reduce to the corner of the wall with the aerial on and trim the front


- T11. Large Sycamore to the side of the house with rot at the base – to fell and grind out the root bowl. To Remove 3 small branches at 3 metres from the neighbouring Sycamore.
- T12. Two small Birch trees behind the Sycamore – to fell and grind out the root bowls
- 13. Taking all arisings away leaving site clean and tidy
