Proposal:

Erection of temporary construction hoist and associated fencing from basement yard to ground floor of Faculty of Built Environment for two year period from June 2011. Drawing Nos: SLP01-P1; MB 1500/150; 820601-P1; 820602-P1; 820603-P1; 820604-P1

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The structure hereby permitted is for a temporary period only and shall be removed on or before 30th June 2013.

Reason: The type of structure is not such as the Council is prepared to approve, other than for a limited period, in view of its appearance. The permanent retention



of the structure would be contrary to the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

2 The development hereby permitted shall be carried out in accordance with the following approved plans: SLP01-P1; MB 1500/150; 820601-P1; 820602-P1; 820603-P1; and 820604-P1.

For the avoidance of doubt and in the interest of proper planning.

No. 020 7974 5613 or by email ppp@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
