| T1 Neighbouring Apple | Remove overhanging deadwood |

| T4 Oak | Judiciously reduce front growth over garden by approximately 1m, thin throughout the crown by 20% to allow more light to filter into the garden. Clean throughout the crown removing all major deadwood including large dead limbs extending over the garden |
| T5 Horse Chesnut, Neighbouring Rear Garden | This tree is located in a neighbouring garden and we cannot gain access into this tree. We will however prune what we can with long arm pruners, carrying out the work from the oak tree |
| T6 Hawthorn | Trim growth growing towards lawn area |
| T7 Oak, Left hand rear boundary | Reduce by approx 40%, 3m from the height and round over the sides to alleviate weight and lessen the risk of future failure |
| T8 Neighbouring Oak | Crown lift up to 5m, thin throughout the remaining canopy by approximately 20% |
| T9 Neighbouring dead tree | Remove |
| G1 Neighbouring mixed vegetation | Cut back |
