 - Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.
- The development hereby permitted shall be carried out in accordance with the following approved plans Site location plan; P2; P3; P4B; P5C; P6A; P7A; P8; P10.
