THE EXTRACT IS TO BE SUPPORTED ON SOUND DAMPED BRACKETS FIXED TO THE INSIDE OF THE REAR OUTSIDE WALL AND TO USE WITHIN BUT NOT TOUCHING A SOUND AND FIRE PROOFED ENCLOSURE FORMED IN THE SECOND FLOOR BACK ROOM AND ROOFSpace. ABOVE THE ROOF THE 500 X 500 MM SECTION SHOULD BE FINISHED IN MATTBLACK.
