## **Full Planning Permission Granted**

Proposal:

Refurbishment of building including replacement doors and windows, new Juliet balcony to front elevation, replacement of rear courtyard ground floor windows with new doors, replacement external stair case to rear courtyard, replacement of existing roof tiles, making good of existing chimney breast and roof ridge feature, installation of new conservation style roof light, replacement of existing roof light on the northern roof slope and installation of solar panels to the southern roof slope at existing community centre (Class D1) Drawing Nos: Site location Plan; 12620/01; 12620/02AI; 12620/03E; 12620/04D; 12620/05D; 12620/09;

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three



years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

3 All architectural features on the roof, including the chimney and mid roof parapet shall be retained and repaired to match the original work.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

4 All windows and doors hereby approved shall be of timber construction and be single glazed or narrow double glazed sealed units unless otherwise approved in writing by the Council.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

5 The development hereby permitted shall be carried out in accordance with the following approved plans: Site location Plan; 12620/01; 12620/02A; 12620/03E; 12620/04D; 12620/05D; 12620/09;

Reason: For the avoidance of doubt and in the interest of proper planning.
