At the rear of the pub at 2nd floor level there has always been a flat roof. Previously this only had access via the bathroom window and we frequently used it during the summer time.
We were refurbishing our living quarters on the second floor above the pub and took the opportunity to knock through the external wall and install French doors which lead onto this flat roof. We then decked it and installed a ballustrade.
We took advice from an 'experienced' friend of ours who told us that we would not need planning permission for this as it was an existing structure. This was clearly wrong and so apologies for the retrospective application.
