We plan to carry out the following works at **9 Daleham Gardens, London, NW3 5BY**. Can you please confirm is there are any TPO's/conservation areas relating to the trees.

Species: Tilia (Lime)

Position: Front Garden - RightHand Side

Reason: Outgrowing Location

Reduce and shape crown(s) by approximately 50%, cutting back to a branch/bud, to leave a flowing branch line without stumps, to B.S.3998:13.4.1.

Remove all major dead and diseased wood and generally clean up crown(s).

Remove lower branches to a height of 4m above ground level, removing entire branches, or part of the same that extend below the specific clearance height, to B.S.3998:13.5.

Species: Pittosporum

Position: Rear Garden – Left Hand Side (near house)

Reason: Outgrowing Location

Reduce and shape crown(s) by approximately 50%, cutting back to a branch/bud, to leave a flowing branch line without stumps, to B.S.3998:13.4.1.

Remove all major dead and diseased wood and generally clean up crown(s).

Species: Laurus Nobilis (Bay)

Position: Rear Garden – Right Hand Side

Reason: Shade Nuisance

Remove lower branches to a height of 4 - 5m above ground level, removing entire branches, or part of the same that extend below the specific clearance height, to B.S.3998:13.5.

Species: Pittosporum

Position: Rear Garden – Right Hand Side

Reason: Shade Nuisance

Remove lower branches to a height of 4 - 5m above ground level, removing entire branches, or part of the same that extend below the specific clearance height, to B.S.3998:13.5.

Species: St. Johns Wort (Hypericum)

Position: Rear Garden - Right Hand Side

Reason: Outgrowing Location

Reduce and shape crown(s) by approximately 50%, cutting back to a branch/bud, to leave a flowing branch line without stumps, to B.S.3998:13.4.1.

Remove all major dead and diseased wood and generally clean up crown(s).

Species: Lonicera
Position: Rear Garden - Right Hand Side
Reason: Outgrowing Location

Reduce and shape crown(s) by approximately 50%, cutting back to a branch/bud, to leave a flowing branch line without stumps, to B.S.3998:13.4.1.

Remove all major dead and diseased wood and generally clean up crown(s).

Species: Hedera (Ivy)
Position: Rear Boundary
Reason: View

Trim top and side(s) to a uniform shape, excluding neighbour's side(s) unless specified, removing cuttings from finished hedge and ground.

Cut to ground and poison any minor invasive alien growth with SBK herbicide.
