Holm Oak - Aprox 5m - Situated in garden of ground floor flat, 4 Lyndhurst Road - Reduce to as near to boundary as is practicable, reduce crown spread by aprox 20% and thin crown density by 20%.
Silver Birch - Aprox 12m - Situated in 21 Thurlow Road - Remove one low overhanging branch at aprox 5m, reduce remaining overhanging limbs by 20% and thin crown density by 20% and thin crown density by 15-20%.
Reasons- to increase light levels to the garden and help control encroachment.
All trees can be seen by views from Mr Harleys property 4a Lyndhurst Road.
