# ESTIMATE

#### RE:- FIVE-A-SIDE AREA FLOODLIGHTING

Further to our recent site visit, we take pleasure in submitting our estimate as follows:-

To supply and erect 4 No. 8 metre high BEI tubular steel static pole planted root lighting columns.

To supply and install 4 No. Philips OptiVision MVP507 1000 watt medium beam asymmetric low glare floodlight luminaries complete with associated control gear and MHN-FC lamps.

The proposed installation will achieve an average maintained horizontal illuminance of 203 lux with a min/ave. uniformity factor of 0.72 and a min/max uniformity factor of 0.65.

The installation will consist of excavating 4 No. column foundation holes; cable laying around the outer perimeter of the proposed playing area and back to the single phase power supply position within the Porta Cabin area; at this point a 63 amp single phase distribution board will be installed complete with all associated MCB's and contactors to allow the switching of the installation to come via key switch operation.

To test and supply commissioning reports on completion of works.

This estimate is fully inclusive of all labour, materials and plant to carry out the proposed installation.

The total installed power for the proposed installation is 4.42 kilo watts.
