Re: Proposed installation of floodlights in the school's five-a-side football pitch.

The School is considering the installation of floodlights in the football five-a-side football pitch and would like to enquire about planning permission and to establish if it is necessary for the above procedure.

Reasons for floodlights:

The School would like to utilise the pitch principally during the Autumn and Spring time, but with natural light in the evening at a premium, and hazardous play a possibility, illuminating the pitch would provide a visible and safer environment.

The Floodlight Specification is as follows:

The floodlights would be erected on 4No. metal poles deep-rooted in a concrete base in the four corners of the pitch positioned inwards.

The fittings would be 'Halide Floodlights' with toughened glass fronts, epoxy painted black aluminium with an anodized aluminium reflector, and all fitted with 1no. 400watt lamp each.

Location of Football Pitch:

The pitch is situated in the distant corner of the School site alongside the Menelik Road boundary and sports field and does not cause any problems.
