1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

2 The development hereby permitted shall be carried out in accordance with the following approved plans: 8NH/P100 (Site Location Plan); S101; S201A; S202; S301; P101; P201A; P202; P301.

Reason: For the avoidance of doubt and in the interest of proper planning.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1 (General design principles), B3 (Alterations and extensions) and B7 (Conservation areas) of the London Borough of Camden Replacement Unitary Development Plan 2006.

4 The second floor bathroom window on the southern side elevation of the building hereby approved shall be obscure glazed and be non-opening to a minimum height of 1.7m above internal floor level and shall thereafter be permanently retained as installed.

Reason: To safeguard the amenity of the adjoining premises at no. 22 Park Village East in accordance with the requirements of policy SD6 (Amenity for occupiers and neighbours) of the London Borough of Camden Replacement Unitary Development Plan 2006.

1 Reasons for granting permission.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies SD6 (Amenity for occupiers and neighbours), B1 (General design principles), B3 (Alterations and extensions), B7 (Conservation areas).
