There are two areas in which new works are proposed.

1. Recessing existing fourth floor mansard roof further from street. Replacement of existing fourth floor front windows with full height outward opening glass doors. Additional discrete metal balustrade to the parapet wall.
2. Replacement of existing ground floor front window and front door. The existing leaded window is both cracked and in disrepair. The leading is of poor quality and out of proportion with the architectural composition of the ground floor windows of the rest of the street. The proposal is to replace the window with a metal framed 3 angled bay that is more sympathetic to the three window composition of the street and the rest of the house. This will also improve the security of the house. A new front door is also proposed.

Existing mansard roof (built as an extension in the 1970's) is in disrepair. To improve the light into the top floor room and to improve the water proofing/insulation of the roof, it is proposed to cut the mansard pitch back to a square elevation on the front of the house. The existing buildup of the roof construction is timber, ply and slate tiles.

The new roof section will be built from timber frame lined with marine ply and clad with either slate tiles or roofing felt.
