Proposal:

Retention of roller shutter doors with pedestrian gates on the front and side elevation and windows at the side elevation, and infill extension at side elevation over part of the service yard at ground floor level.

The Council has considered your application and decided to **refuse** planning permission for the following reason:

Reason for Refusal

The infilling of the former undercover yard area and the retention of the roller shutter within the south elevation is detrimental to the amenity of the residents at the



Ziggurat, 60-66 Saffron Hill. This is by reason of noise and disturbance directly caused by the operation of the roller shutter and pedestrian entrance and consequential noise and disturbance arising from the impact of the unauthorised development (in such a confined location) including the effect of operation of the roller shutter and the effect of activities displaced from the former undercover yard area to the open area of the courtyard. This is contrary to policies SD6 (Amenity for occupiers and neighbours) and SD7 (Light, noise and vibration pollution) of the LB Camden Replacement Unitary Development plan 2006.
