### **Annex 1 - Mandatory conditions**

1. The supply of alcohol is prohibited at a time when there is no designated premises supervisor in respect of the premises.
2. The supply of alcohol is prohibited at a time when the designated premises supervisor does not hold a personal licence or his/her licence is suspended.
3. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
4. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each individual must be licenced by the Security Industry Authority.
5. But nothing in subsection (4) requires such a condition to be imposed -
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to -
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
6. For the purposes of this section -
  - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

### **Annex 2 - Conditions consistent with the operating schedule**

7. Notwithstanding the terms and conditions of this Premises Licence the premises shall not be open to members of the public outside of the opening hours specified in the planning permission in force at the time of use.
8. No children under the age of 16 shall be permitted on the premises after 21.00.
9. Tables within the premises shall be provided with bag clips.

10. Customers carrying open bottles shall not be permitted onto the premises at any time when the premises is open to the Public.
11. The premises shall maintain the operation of their CCTV system.
12. Alcohol and any other drinks shall not be allowed to be removed from the premises in any open containers.
13. On any date and time that the licensable activities go beyond midnight, Registered Door Supervisors shall be employed.
