



NOTES:

1/ Natural aluminium finish projecting sign with folded return at 90 degrees for fixing to existing structure. Fixings to be external expanding masonry bolt in stainless steel with flat heads and washers. Care to be taken to cause minimum damage to existing facade.

Artwork applied to steel sign in external grade self adhesive vinyl decal.

Note: sign to be read both sides as shown in sections

2/ On removal of sign all fixing holes to be invisibly filled and all surface adjacent to sign to be decorated to match into existing surrounding colour so as to be undetectable
